You are invited to be a Marketplace vendor at the eighth Annual Florida Herbal Conference!

The mission of this conference is to uplift our Florida herbal community by providing a space for us to deepen our connections and to deepen our knowledge of Florida's healing flora. Organized by The Florida School of Holistic Living, a 501(c)(3) nonprofit organization offering herbal education to the Florida community since 1999. With a main campus in Downtown Orlando and satellite campuses in Tallahassee, Sarasota and Miami offering full herbalism curriculums, garden instruction, a seed library, and community herbal clinics.

The 2019 Florida Herbal Conference will feature dozens of the most respected master herbalists offering over 40 classes and workshops to more than 700 people from the southeast U.S. region. This 3day/2night weekend conference takes place at Retreats by the Lake in Lake Wales Florida which facilitates camping amenities for all of our attendees and a marketplace area designated for over 30 vendors. Along with our headlining keynote speakers and renowned herbalists Angelique 'Sobande' Greer and Jody Noe, this event will also feature many popular Florida musicians and several youth programs for kids joining their parents.

Since our first event in 2012, the Florida Herbal Conference has grown by 300% with a whopping 700 people in attendance at the 2018 event. Overall the conference generated an estimated \$50,000 in food, vendor, and ticket sales. Profits from this conference will be donated to United Plant Savers (UnitedPlantSavers.org) to help them continue their work in our herbal community.

MARKETPLACE SPECIFICS

One of the highlights of the Florida Herbal Conference is our dynamic and vibrant herbal marketplace.

Comprised of vendors from around our region, we highlight handmade crafts and herbal artisan goods. We focus on selecting vendors who provide an authentic quality products that you can't find anywhere else. APPLICATIONS

Applications are considered on a first come, first served basis. We have limited spaces and they will fill quickly – submit your request as early as possible. Our deadline for receiving your application is October 20th for priority placement. We will respond with our decision by October 31st. Once your application is accepted, your vendor fee will be required to reserve your space.

PAYMENT

Marketplace spaces for this special event are \$325 each, which includes one general registration to the conference and a 10 x 10 booth space. One additional vending staff may register with you for a discounted \$125 fee. Mail check or money order to Florida Herbal Conference c/o PO Box 754, Goldenrod, FL 33453. Payment in full must be received no later than December 31, 2018.

SET UP

Marketplace vendors will provide their own tent and equipment. Tents, tables, and chairs will not be provided, however tables can be rented with advance notice. Set up no later than noon on Friday February 22, 2019. Breakdown may occur no earlier than the 3pm Closing circle on Sunday February 24, 2019. Power is not provided. OFFICIAL TERMS AND CONDITIONS

- Statement of Policy:** All Vendors are equal regardless of size and should be given equal opportunity, within reason, to present their product or service in the most effective manner to the audience. We ask you to be a "good neighbor" and remember, we want you to be successful.
- Contract Conditions:** The following contract conditions have been formulated for the protection and best interests of all concerned. As such, the terms and conditions shall apply to and be in effect among The Florida Herbal Conference and any Vendor whose application is received and to whom space is granted. All points not covered are subject to the decision of The Conference Directors.
- Safety Precautions:** Exhibitors shall take precautions for the safety of their personnel, other Exhibitors and all other persons upon the premises, and shall comply with all applicable provisions of Federal, State and Municipal safety laws, building codes and ordinances.
- Maintenance Of Space:** Exhibitors shall keep their space clean and orderly at all times and shall not engage in activity which would unduly interfere with visitors or other Exhibitors, or would be in violation of law, regulation or ordinances.
- Vending Guidelines:** The Exhibitor agrees to produce his exhibit in dignified taste and in keeping with the reputation and image of The Florida Herbal Conference and to provide staff to be present in the space during event hours. All persons (including children) in your party must register for conference to be onsite. Exhibitor agrees to dismantle space only after closing circle on Sunday February 24, 2019. No early breakdown is permitted and food trucks may not be permitted to leave event until closing circle on Sunday.
- Enforcement:** The Exhibitor agrees to comply strictly with applicable terms and conditions contained in the agreements between Camp La Llanada, the Sponsor, and Conference Directors regarding the Vending premises. Conference Directors reserve the right to restrict exhibits, which because of noise, method of operation, materials or any other reason, become objectionable and also to prohibit or evict any exhibit which in the opinion of the Conference Directors may detract from the general character of The Florida Herbal Conference as a whole. This reservation includes persons, things, conduct, printed matter, or anything of a character which the Conference Directors determine is objectionable to the Conference or does not conform to the standards of The Florida Herbal Conference. In the event of such restriction or eviction, the Conference Directors are not liable for any refund or other exhibit expenses.
- Illegal Merchandise:** Merchandise or services prohibited by law are not allowed at The Florida Herbal Conference.
- Sales:** Exhibitors may sell merchandise. Exhibitor is responsible for collecting sales tax on all purchases. No alcoholic beverage is allowed within Exhibition facility to sample, distribute or sell by Exhibitors without prior written approval from show management. Food and/or beverage sales and distribution must comply with venue policies. All exhibitors selling or sampling food or beverages must provide a copy of their current Health Department permit or must apply for and provide a copy of an applicable temporary health permit.
- Firearms, fireworks, incendiary devises:** The Florida Herbal Conference prohibits the display or use of firearms, ammunition, fireworks, bombs or other incendiary devices on the premises. Exceptions may be granted by Florida Herbal Conference upon request and prior written approval by Conference Directors.
- Liability:** The Conference Directors, Sponsors, Camp La Llanada, and their officers and staff members disclaim all liability for damages or losses caused any Vendor by fire, water, flood, windstorm, utility failures, rodents, acts of vandalism, insurrection, civil disorders, strikes, criminal acts, theft.
- Marketplace Vendor Cancellations:** All cancellations must be in writing. A \$100 fee will be assessed to all Marketplace Vendor cancellations. Cancellations received 60 days or more prior to the conference will be refunded full deposit received less a \$100 cancellation fee. Cancellations received between 30 and 60 days prior to the conference will receive 50% of their deposit minus a \$100 cancellation fee and any sum paid over their deposit. Cancellations received within 30 days of the Conference will receive no refund. Failure to set-up by the specified move-in deadline will result in forfeiture of vending space and all monies paid to date. Conference Directors reserve the right to dispose of such space, with no refund to the vendor. No full or partial refunds will be given for any reason within 30 days of the event.
- Interpretation and Amendments:** Conference Directors shall have the full power to interpret and enforce all rules contained herein, and the power to make amendments thereto, and to enact such rules and regulations as shall be considered necessary for the proper conduct of Event.
